#### Communication

We may ask you to provide explicit permission for us to use your Personal Information to contact you with newsletters, marketing or promotional materials and other information that may be of interest to you. You have the right to access the information we hold about you, and you have the right to have all the data we hold about you erased

#### Personal Information we collect

For a better experience while using our service, we may require you to provide us with certain personal information, including but not limited to, title, first name, last name, email address, phone number, postal address, date of birth, service you are interested in, name, phone number, and postal address, demographic information, device ID, IP address, future communication preferences and any other information that you consider necessary to provide to us. We collect this data when:

All personal information you supply to us will be treated in accordance with the Data Protection Act (1998) and the General Data Protection Regulations (2018).

### How and why do we use your data

We use your personal data to do the following:

- To carry out our contractual obligations arising from contracts that we enter into with you, for example to process and deliver a service your purchased with us online, by phone or face to face.
- To comply with our legal obligations arising from contracts that we enter into with you. For example, keeping records of transactions for VAT reporting purposes.
- To respond to any enquiries, you make.
  - To help us identify you and accounts that you hold with us.
  - To provide you with information about other products and services we offer that we think you might be interested in.
  - To personalise our website, online advertising and email communications to you, to offer you a more relevant experience
  - To measure and understand how our customers interact with us, through data analysis, data aggregation and customer profiling.
  - To detect, prevent and identify fraud.

### Legal basis to processing your data

- When you make a purchase from us, we will process your data to fulfil our **contractual obligations** for the contract that we have entered into. For example, using your address to deliver a purchase to you.
- When you make a purchase from us, we will process your data to fulfil the **legal obligations** that we are bound to comply with, such as tax reporting for VAT purposes.
- When you make a purchase from us, we will process your data under the basis of **legitimate interest**. Legitimate interest is the interest of our company to conduct and manage our business and provide you with the best and most secure customer experience possible. When we process your information under legitimate interest, we take care to balance our actions with your rights and interests under data protection law.
- We may choose to send you marketing communications on the basis of legitimate interest. You will be given the right to **opt-out** of these communications i) when you first enter in to the contract and ii) at any time afterwards by contacting support@off-you-go.com or writing to us at the address provided above.
- We may also use your data under legitimate interest to perform data analysis of our customers, to help us understand how our customers interact with us, and to provide you with a better customer experience.
- We may use your data to ensure the smooth and secure running of our website, for example through website analytics and fraud checks at the time of an online purchase.
- We will always keep your data secure and in accordance with the details contained in this policy.

#### Consent

We will never share your personal information with any other organisation for the purposes of marketing, unless we obtain your explicit prior consent.

#### How do we ensure your data is kept secure

#### What are your rights when it comes to personal data

#### • The right to access your data.

• The right to correct your data

If you have any changes to your personal data or you think anything we hold about you is incorrect, please let us know so that we can rectify it.

#### • The right to erase your data

You have the right to ask us to delete all the personal information we hold about you. Unless we are required to keep your data for any legal obligations, we will action this request as quickly as possible within 30 days of receiving your request. If you request that we delete your data, we will keep the minimum amount of data required to make sure that you are not contacted by us again.

#### • The right to restrict how we use your data

If you believe that the data we hold about you is inaccurate or we are not using it for the reasons described in this policy, you can request to restrict how we use your personal data.

#### The right to data portability

You can ask us to send you the personal information we hold about you or to transfer it to a third party. We will provide the data we have in a structured, commonly used and machine-readable format (such as a CSV file) which we will either send directly to you or pass to another data controller at your request.

#### The right to object

You have the right to object to how we use your personal data. You can opt out of marketing communications at any time by contacting support@off-you-go.com or writing to us at the address provided above.

## **Cookie Policy**

A cookie is a piece of information that is stored on your computer's hard drive by your web browser, which tracks how you use websites. #### **Service Providers**
